The Academic Senate for California Community Colleges (ASCCC), in partnership with the Student Senate for California Community Colleges, RP Group, and the CCC Chancellor's Office, is hosting its 2019 Academic Academy with a focus on student experience on September 13-14, 2019 in Long Beach, CA. The event will be taking place on the Queen Mary, 11126 Queens Hwy, Long Beach, CA 90802.

University of California Transfer Pathways (UCTP)

In April 2018, the California Community Colleges (CCC) and University of California (UC) signed a Memorandum of Understanding (MOU) to enhance student transfer and increase academic preparation for CCC students as they transfer into a UC campus. As a result, the UCTP Guarantee pilot project in Chemistry and Physics was created based on several priorities shared by the two systems. Since their release, questions from the field have required updates to the templates for better clarification. The changes include:

- Clarification regarding the GPA of 3.5 in the major;
- Confirmation that the language requirement can be completed in high school;
- Verification that C-ID Math 910-S is acceptable for Math 240 and Math 250.
