### DISCIPLINE STATUS REPORT:

#### Agriculture

All Agriculture descriptors are currently due for review. The proposed TMCs for the discipline have been used to identify the descriptors that will be maintained in C-ID. As soon as the review process is adopted, the descriptors will be posted for vetting.

#### Biology

The Biology TMC will soon be posted again for vetting along with BIOL 150 (Zoology/Animal Diversity and Evolution), BIOL 155 (Botany/Plant Diversity and Ecology) and a new descriptor BIOL 135S (Biology Sequence for Majors). The FDRG has also been asked to reconsider the prerequisite determinations made for the various anatomy and physiology descriptors.

#### Chemistry

CHEM 130 (Quantitative Analysis) closed vetting on October 25th. IGETC for STEM was approved for use by ICAS—the TMC will be available for use in the very near future.

#### Child and Adolescent Development

The FDRG is meeting in person in November to continue the work on the TMC for the discipline.

#### Child and Adolescent Development con't.

Once a draft is created, the TMC will be posted for vetting.

#### Information Technology/Information Systems

The FDRG met in person at the end of October to discuss the potential for an ICT (Information Communication Technologies) model curriculum. More information to come.

#### Nursing

### FREQUENTLY ASKED QUESTIONS

**Q:** Can Academic Departments/Department Chairs modify the major for Associate Degree's for Transfer (ADT's). For example, if a college approved the Business Administration ADT without a particular course but the student wants to substitute it for one that *is not* on the approved ADT, can the Department approve a "modification of major" and substitute a course as they would normally do for other local degrees?

**A:** Per the "Reciprocity, Course Substitution, and Credit by Exam—in light of AA-T and AS-T degrees" document, substitutions are permitted as long as the degree granted is consistent with the TMC. In other words, the CCC's obligation is to issue a degree that is TMC-aligned. The degree granted by an individual CCC may vary from its approved ADT as a consequence of honoring course selections made by another CCC or allowing local exceptions that are within the parameters of the TMC, but not specified in its degree. Given that local degrees should be designed to best prepare students for their most likely transfer destination, it is expected that there may be options permitted by the TMC that are not integrated into the local ADT.
